

## TERMS & CONDITIONS

### Tour to Mauritius | 7<sup>th</sup> April to 12<sup>th</sup> April, 2026

By confirming participation in the above-mentioned tour, the client agrees to the following terms and conditions:

1. Dates and timings for to and fro flights may be subject to change as per the policies of air lines prevailing at that time.
2. Clients are required to provide **full name of each passenger, age, gender, and mobile number and mail id** at the time of booking.
3. **Contact details of immediate relatives** must be provided for use in case of emergencies.
4. We shall make every effort to cover all places mentioned in the itinerary. However, in case of **bad weather, local restrictions, or unforeseen circumstances**, we reserve the right to **alter or reschedule the itinerary** in the best interest of passenger safety and logistics.
5. All passengers are requested to wear **full and appropriate dress** while visiting sacred places in Mauritius, including the site of the **13th Jyotirlinga**.
6. **Pure vegetarian lunch** will be arranged during the tour. At hotels, passengers are free to consume food as per their personal preference.
7. As good vegetarian restaurants are not available everywhere in Mauritius, **packed vegetarian lunch** will be arranged daily when the tour commences.
8. Passengers are requested to **strictly adhere to reporting and departure timings** to ensure smooth completion of the daily sightseeing schedule.
9. **Eating, drinking, and smoking inside the tour vehicle is strictly prohibited** and is a punishable offence under Mauritian law.
10. Passengers intending to make purchases in Mauritius are advised to **carry Indian Rupees (INR)** and exchange the same at the Mauritius Airport for local currency (MUR).
11. We **do not provide any FOREX or currency exchange facility** to travellers.
12. **GST 5 % on total amount of package and TCS 5 % on hotel stay charges are collected separately** over and above the tour package amount and are deposited with the Government. Hence, copies of **passport, Aadhaar card, and PAN card** are mandatory for all passengers.
13. Passengers must ensure that their **passport is valid at least till December 2026**.

14. Passengers are required to carry **last 6 months' updated bank statements**, duly stamped and sealed by their banker, if required to present before immigration authorities for obtaining tourist permit on arrival. It is free of cost.
15. In case of bad weather or any situation where the **Mauritius Government postpones flights**, airlines may issue fresh tickets. However, **additional hotel stay costs, if any, shall be borne by passengers directly**.
16. Passengers must **not carry any items prohibited** by Mauritian authorities or airlines. Any violation shall be the sole responsibility of the passenger.
17. Passengers are required to **carefully read and accept the cancellation policy**, which shall be shared separately and shall form an integral part of these terms and conditions. The total cost of per person is Rs.1,22,400/- plus gst and tcs.
  - a. Rs. 5,490/- immediate due as token of advance to book your seat
  - b. 50 % amount after deducting Rs 5,490/- due on Feb 20, 2026 i.e. Rs. 58,455/- plus gst and tcs.

At this juncture even after payment, if any one wants to withdraw his/her name and cancel bookings , then he/she has to forgo booking amount of Rs. 5490/-.  
We will return back balance amount with gst and tcs collected.
  - c. For those who wants to continue with this tour, are requested to pay balance amount of tour i.e. Rs. 58,455/- plus tcs and gst by Mar 1, 2026.

At this juncture even if some wants to cancel his/her bookings, he/she, has to follow cancellation policies of airlines, hotels, car owners, travel insurance companies for the purpose.
  - d. NO cancellation allowed after March 20, 2026. Means he/she wants to opt this tour after this tour shall not get any refund of any amount at any point of time.
  - e. **Special discount of Rs. 2,520/- for those who will be with this tour and same will be paid to them on the day of arrival at Mauritius.**
18. Passengers are advised to **carry dry snacks** as per their individual requirements during the tour.
19. All accommodation arrangements are on a **twin-sharing basis**, unless otherwise specifically agreed.
20. Passengers must carry **copies of air tickets and hotel vouchers, Mauritius all in one form** for presentation to immigration and other authorities if required.
21. We will be issuing one common declaration for all pax for the related authorities at Mauritius also.

22. The **Mauritian All-in-One Travel Form** must be filled individually by each passenger. A copy should be emailed to us in advance, and a **printed copy must be carried** during travel.
23. **Change of vehicle and/or driver** may occur under exceptional or unavoidable circumstances, without affecting the overall tour services.
